### **Parks Fit for the Future**

The [Local Government Association](#) is the organisation which represents all our local councillors on a national level. They have just completed a detailed study of our parks and greenspaces and the results are very clear.

- 30% more people were active in our parks during the first lockdown
- 62% of the adult population of England visited a greenspace in October last year
- 42% of adults say that their greenspace has been important to them during lockdown

Despite this the future of many of our greenspaces is uncertain because funding is a problem.

The LGA is calling on the Government to introduce a local, flexible **£500 million Green Parks Fund** to help councils to invest in small scale initiatives to help the nation's parks and green spaces recover, flourish and to ensure a healthier more active nation.

"Parks have been lifelines for residents during the the pandemic, but many face uncertain futures." Cllr. Gerald Vernon-Jackson, Chair of the LGA Culture, Tourism and Sport Board.

In Rochester, **the Friends of the Vines** had their first ever Zoom meeting at the end of January and are hoping that it will be possible to hold their famous Cherry Picnic in July. The **Friends of Watts Meadow** have also met regularly to plan the coming year, including ways to help their bat population!

New signs are going up at **Borstal Recreation Ground** which will explain some of its history, and similar signs are being designed by the **Friends of Millennium Green** in Luton, The **Friends of Rainham Recreation Ground** have planted a willow den next to the children's play area and have a fairy trail for children to follow over half term.



At **Broomhill** there has been some clearing of fallen trees across paths by a very good local contractor. Bark chipping are available for path surfacing and shrub beds so contact the Forum for [more information](#).

In **Wainscott**, where a new Friends group is about to be launched, there is planting of a new community orchard, with cob nuts and fruit trees, Something we could all do on our greenspaces to encourage some local foraging!

### COP 26

COP 26 is the next annual UN Climate Change Conference. This year the UK holds the presidency of the conference which will be held in Glasgow from the 1-12th November.

COP stands for Conference of Parties and it brings together all the heads of state, climate experts and campaign groups to continue their work to address the problems and causes of climate change.

This year the conference is particularly important as the new US President will be attending and many believe that this will fundamentally change the whole approach on climate change for the better.
